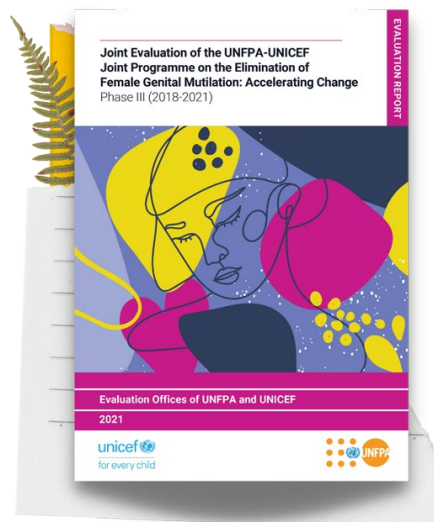

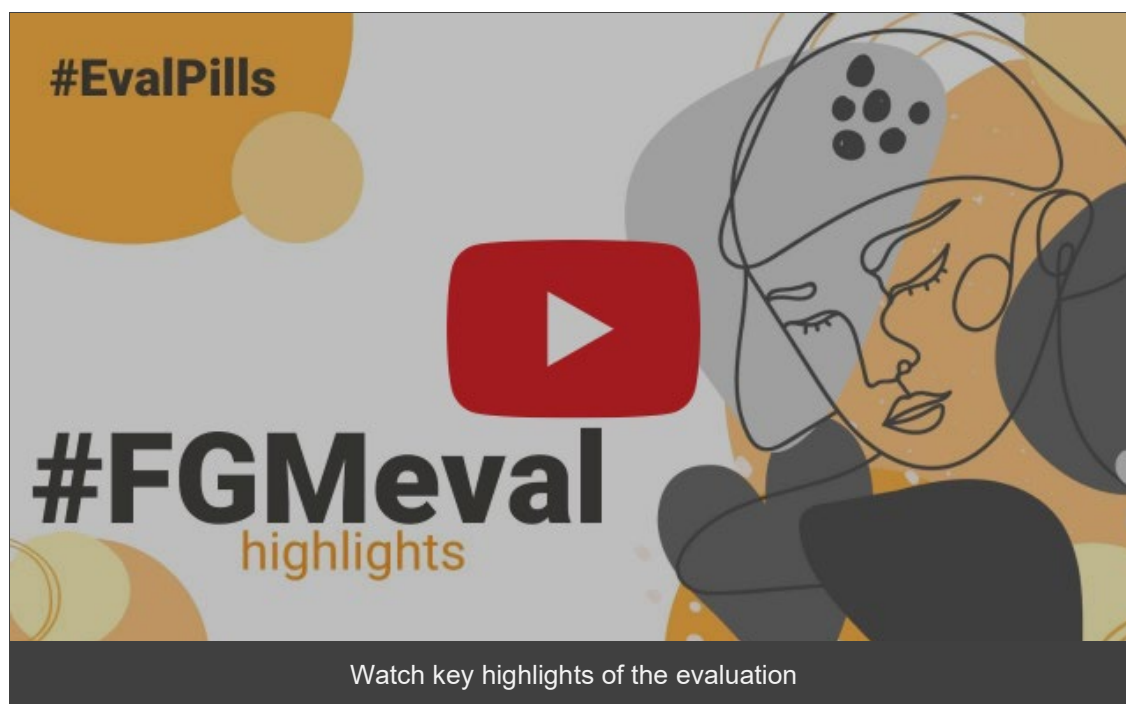

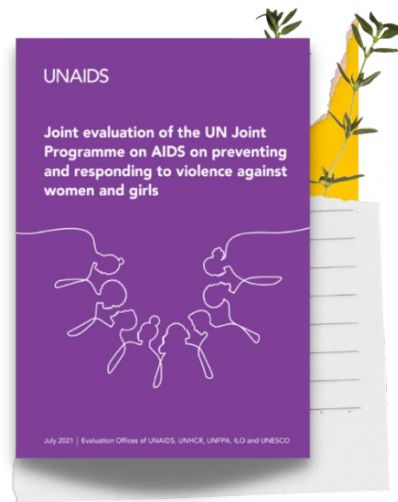

## Joint evaluation of the UN Joint Programme on AIDS on preventing and responding to violence against women and girls

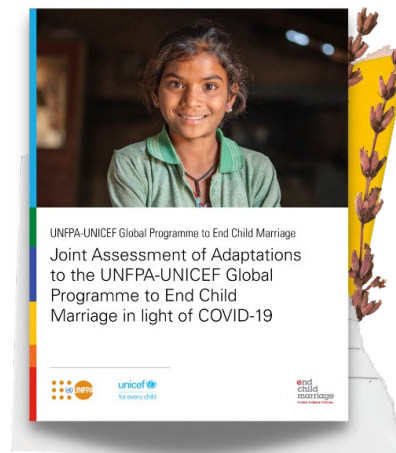
