



Procurement undertaken by UNFPA Supply Chain Management Unit, Copenhagen on behalf of UNFPA Country Offices and UNFPA Headquarters for programmes and administrative purposes.

Procurement on behalf of Partners

Procurement undertaken by UNFPA Supply Chain Management Unit, Copenhagen with no direct UNFPA programme component, at the request and on behalf of Governments, inter-governmental organizations, non-governmental organizations, or United Nations entities including specialized agencies, funds, programmes, and subsidiary organs.

Global Procurement

Procurement undertaken by UNFPA Supply Chain Management Unit, Copenhagen.

Local Procurement

Procurement undertaken directly by UNFPA country offices and UNFPA regional offices for programmes and administrative purposes.
